## INVITATION TO BID

### PROCUREMENT, SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF ONE (1) UNIT 100 KVA PRIME GENERATOR SET WITH AUTOMATIC TRANSFER SWITCH

1. The **VICTORIAS CITY WATER DISTRICT (VCWD)**, through the Local Water Utilities Administration and the KfW Entwicklungsbank intends to apply the sum of "**Nine Hundred Twenty One Thousand One Hundred Forty Three Pesos (PhP 921,143.00)**" being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement, Supply, Delivery, Installation, Testing and Commissioning of One (1) Unit 100 KVA Prime Generator Set with Automatic Transfer Switch**. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
2. The **VCWD** now invites bids for the **Procurement, Supply, Delivery, Installation, Testing and Commissioning of One (1) Unit 100 KVA Prime Generator Set with Automatic Transfer Switch**. Delivery of the Goods is required within fifteen (15) calendar days from receipt by the winning bidder of the Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
4. Bidding is open to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138. It is also open to enterprises not domiciled in the Philippines in accordance with the KfW Procurement Guidelines.
5. Interested Bidders may obtain further information from the **VCWD Bids and Awards Committee Secretariat**, VICTORIAS CITY WATER DISTRICT Compound, Victorias City Negros Occidental and inspect the Bidding Documents during office hours at the address given below:
6. A complete set of Bidding Documents may be purchased by interested Bidders on **September 7, 2016 until September 28, 2016** from the address below and upon payment of a nonrefundable fee in the amount of **One Thousand Pesos (PhP 1,000.00)**. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
7. The **VCWD BAC** will hold a Pre-Bid Conference on **September 15, 2016 at 1:30 P.M.** at the Bidding Room at the address below.
8. Bids and eligibility requirements must be delivered to the address below on or before **September 28, 2016 at 1:30 P.M (VCWD Time)**. All Bids must be accompanied by a Bid security in the form of cash, certified check, cashier's check, bank draft/guarantee, or irrevocable letter of credit equivalent to not less than 2% of ABC, or surety bond (5% of ABC) or any combination of the foregoing. Each Bidder shall submit one (1) original and two (2) copies of its bid.
9. Opening of bids shall be on **September 28, 2016 at 1:30 P.M (VCWD Time)**, at the BAC Conference Room, VCWD Compound. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the Bidding Room. Late Bids shall not be accepted.
10. The **VCWD** reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
