RESOLUTION NO. 39 – s. 2018

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO AA ELECTRICAL SUPPLY FOR THE SUPPLY AND DELIVERY OF THREE (3) UNITS OF TRANSFORMERS FOR TERRAVILLE SUBDIVISION.

WHEREAS, the Engineering Division, prepared the Purchase Requisition (PR) for the supply and delivery of THREE (3) units of Transformers for Terraville Subdivision with an approved budget for the contract (ABC) of P270,000.00, which is included in the Annual Procurement Plan for CY 2018;

WHEREAS, on September 13, 2018, the Bids and Awards Committee (BAC) posted/published the Request for Quotation for the said procurement project in PhilGEPS (Ref. No. 5629143);

WHEREAS, a Request for Quotation was received by ASKPS Construction Supply, AA Electrical Supply, Bacolod Electrical Supply and NewBridge Electrical Enterprises;

WHEREAS, AA Electrical Supply, NewBridge Electrical Enterprises and LMS Electrical Supply, Inc. submitted price quotations for the requirement;

WHEREAS, per the evaluation of the VCWD BAC, the proposal of AA Electrical Supply conforms to all the requirements of VCWD and the law, and its price quotation of Php 258,000.00, which is within the ABC , is the most economical and advantageous to the Government , thereby rendering the same as the responsive bid;


WHEREAS, A Post Qualification was conducted by TWG Engineer Edgielu Valenciano and was accompanied by BAC Member C. Fama to verify, validate, and ascertain the physical item if it complies with the Technical Specifications needed;

WHEREAS, Section 12 of RA. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW THEREFORE, for and in consideration of the foregoing, on motion of BAC Member Olvido, duly seconded by Vice-Chairperson Espera, the VCWD-BAC, hereby RECOMMEND to the Head of Procuring Entity RECOMMENDING AA ELECTRICAL SUPPLY as the Lowest Calculated Responsive Bid for the Supply and Delivery of Three (3) Units of Transformers for Terraville Subdivision in the amount of Two Hundred Fifty Eight Thousand Pesos (Php 258,000.00) inclusive of taxes and fees.
